# The Cruise Industry



- Around 350 vessels worldwide
- 29,7 million passengers globally in 2019
- Variety of vessels : from less than 100 pax up to 7000 pax
- Crew: 1/3 of total seafarers – can represent up to one third of the passengers onboard

# The Cruise Industry in Europe



- Second largest destination after the Caribbean with 7.7 Mio pax (in 2019)
- Second largest source market
- 246 vessels operating in European waters
- Operating in 300+ destinations including 64 non-TEN-T ports: Reaching outermost regions and communities of Europe

Include at least 2 different countries – generally a minimum of 3 for a typical 7-days cruise in Europe

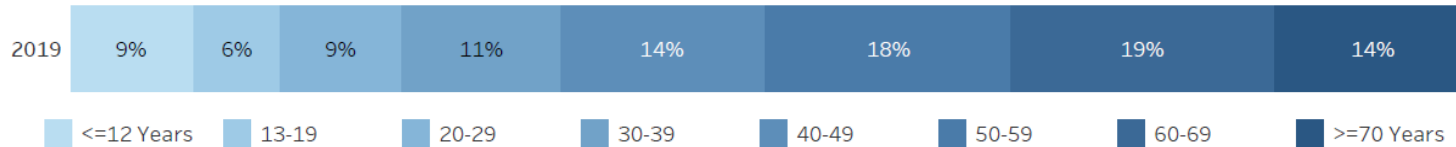

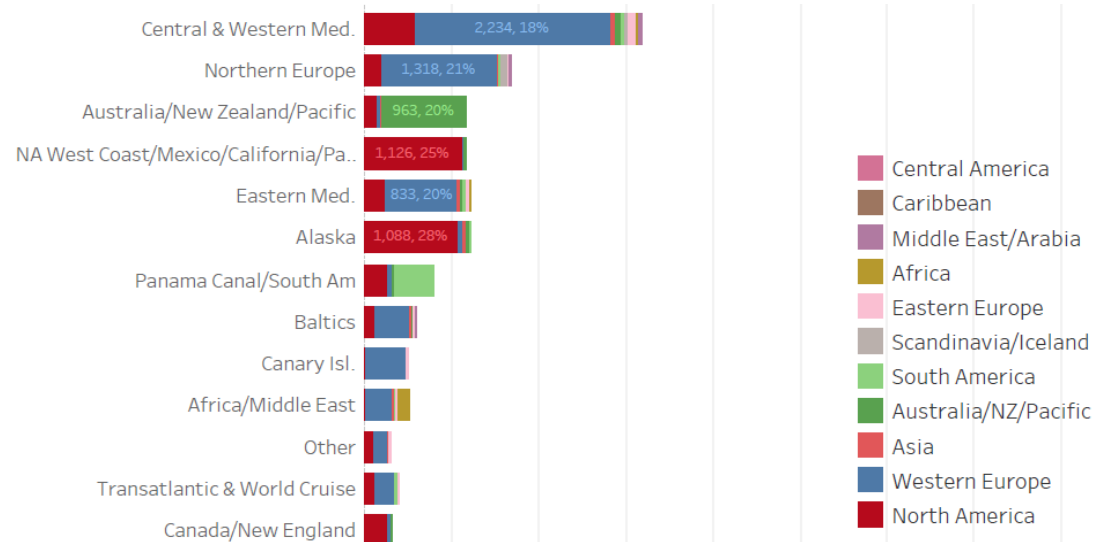
# Cruisers Profile

# Check-in and Passenger Data



- On average up to 3 months prior to cruising up to 60 min prior to scheduled sailing time
- Via website or app – including document capture and checks
- Verification of documentation prior to boarding (over 4-5 hours on average)
- Passenger and crew manifest (IMO FAL Forms 5 & 6) sent up to 24h prior to arrival in port – as per IMO FAL Convention and EU legislation
- Submission via Maritime Single Window / No interactive API capability



# Border Controls Challenges at Ports

## ■ **Entry and Exit recording and passenger registration:**

- When/Where?
  - Considering impact on homeports, on first entry points and status of transit stops outside of Schengen
- How?
  - Resources at ports: number of border guards / kiosks?
  - Segregation of TCN and EU citizens?
  - Consider EES enrollment during the voyage – kiosk or app?

## ■ **Verification of carrier gateway :**

- Timing for verification?
  - Timing for check-in can differ from 3 months up to 60 min.
  - Every time touching a Schengen port during the voyage?
- Consider ETIAS application during the voyage ?
- Integration with Maritime reporting obligations
